Management and staff has been made aware about the provisions of POCSO Act. We are conducting in-house induction sessions on gender sensitization, self-defense training to girls, Constitution of parent-teacher-students committee to address safety needs of students. We are adopting appropriate and detailed protocols and standard operating procedures on issues such as reporting of sexual offences, post incident action plan, safety and security policies, complaints and grievance redressed mechanisms, student counselling, visitor entry etc.

We are adopting the measures proposed by CBSE and any other guidelines that may be issued by the relevant state authorities on safety and security of school children so that the measures taken by the schools are not found lacking. We are holding workshops and trainings for teaching and non-teaching staff on the legal framework and the serious implications arising there under in cases of non-compliance and post incident protocols.

School bus has been written prominently on the back and front of a van or private bus. The buses are equipped with a medical first aid box and a fire extinguisher. The driver has been told not to exceed 50 kmph in speed. Windows are fitted with horizontal grills. The bus driver and conductor have been told to be in proper uniform and are being monitored. All vehicles possess valid annual fitness certificates. The name of the school and contact details have been written on the bus. If it is a hired bus or van, it has on school duty prominently displayed.

Identification badges for administrators, staff, visitors and even students help foster not only a safer environment, but a friendlier environment, too. Ensuring your students know from day one what constitutes unacceptable behavior in regards to violence. In recent years, focus has shifted from physical violence to verbal violence and bullying. We take a proactive approach against bullying by engaging students in team-building activities, responding instantly to hurtful behavior and involving principals and parents when appropriate.
